**Volunteer Agreement**

As a non-profit group that handles many homeless animals, FFAOC does not always have a complete medical or behavioral history for animals with which volunteers work. While some training is provided, a certain amount of risk is always involved especially with unpredictable animals. FFAOC strongly recommends that all volunteers have current tetanus vaccinations and that those with suppressed immune systems consult with a physician prior to volunteering.

In consideration of this opportunity to volunteer at FFAOC, I agree to the following terms and conditions, intending to be legally bound by them:

1. I will abide with the mission, rules, regulations, policies and programs of FFAOC
2. If I stop being a volunteer, or upon request by FFAOC, I will promptly return all FFAOC supplies, equipment, records, animals, moneys, and other items in good, clean condition.
3. I assume the risk of being bitten, scratched, or injured in connection with my volunteer work. FFAOC, and any and all other participating non-profit animal welfare groups/individuals are not liable to me for any injuries, illness, damages, liabilities, losses, judgments, costs or expenses whatsoever, which I might suffer or sustain in connection with my volunteer activities, I will also indemnify, defend and hold the FFAOC, and all others listed above, harmless from and against any claims, lawsuits, injuries, damages, losses, costs or expenses whatsoever, sustained by any animal or person in connection with my misconduct or negligent performance of my volunteer activities, or my breach of FFAOC rules, regulations, policies and programs.
4. I understand that FFAOC may refuse volunteer applications for any legal reason.
5. I have accurately and truthfully completed this Volunteer Application and Agreement.
